

Kids Connection Preschool Program
Registration 2012-2013

Here is the registration information for the Kids Connection program beginning in September 2012. We offer classes on Tuesday & Thursday morning (9-11am) and afternoon (12-2pm) for children 3 years old on or before September 1. For children that turn 4 on or before September 1 we offer Monday/Wednesday/Friday morning (9-11:30am) and afternoon (12:15-2:45pm); Monday/Wednesday Evening (5-7pm); M-F afternoon (12:15-2:45pm) and our new option Tuesday/Thursday afternoon (12:15-2:45pm).

Our registration process will be drop-off. Please have all of your paperwork completed and all copies attached before dropping off.

Registration start dates are February 20 for residents and February 27 for non-residents. We will take registration until the program is full.

You may pay for the Kids Connection program in full or you may choose to pay with our automatic monthly credit or debit card plan (EFT). If you plan to pay in full, payment is due in its entirety at registration. If you plan to use the EFT (monthly) method of payment, please complete the EFT form and first month's payment due at the time of registration. **This first month's payment is a non-refundable deposit.** For students enrolled for a class that meets on a MWF EFT deductions will be debited from accounts on the 3rd Wednesday of every month from September 2012-April 2013 and for those enrolled in a Tu/Th class deductions will be on the 3rd Thursday of every month from September-April. If your card is declined for any reason, a \$25 decline fee will be assessed.

In order to reserve your spot for the 2012-2013 school year without paying in full, you must pay the 1st month's payment at the time of registration.

No registration form will be processed without payment in full or a completed EFT form with 1st month's payment, a copy of child's birth certificate, and a recent utility bill to show proof of residence.

Completed registration forms will be accepted by the front desk staff at Arrowhead Community Center only.

Please note on the registration form your first and second class time choices. We will only contact you if you do not get your first choice.

Due to the amount of children that we have in our program, we will NOT accept special requests for teachers or classrooms under any circumstances. All teacher/classroom assignments are made randomly and will be mailed in August 2012. In the case of twins, triplets, etc., parents have the choice of keeping the children in the same classroom or putting them in separate classrooms, however, they will not be able to request teacher or classroom location.

You can expect to receive a postcard in August telling you your child's classroom assignment and preschool time. At that time please visit our website, www.channahonpark.org for other forms including the Preschool Parent Handbook, Child Emergency Information form and school supply list. Once at our website roll over programs, click early childhood, click Kids Connection Preschool 2012-2013. This paper work must be completed in order for your child to attend preschool.

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these programs/activities against the Channahon Park District, including its officials, agents, volunteers and employees (hereinafter collectively referred as "Channahon Park District").

I do hereby fully release and forever discharge the Channahon Park District from any and all claims for injuries, damages, or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with these programs/activities.

I would also like to remind you that if your card is declined for any reason you will incur a \$25.00 decline fee.
