

Kids Connection Preschool Program  
Priority Registration 2018-2019

Here is the registration information for the Kids Connection program beginning in September 2018. As a current Kids Connection participant, you get early registration for your currently enrolled student and any siblings. Registration will take place at Arrowhead Community Center from February 19-23. Any registrations dropped off after February 23 are no longer considered priority.

Our registration process will be drop-off. Please have all of your paperwork completed and all copies attached before dropping off. No registration form will be processed without payment in full or a completed EFT form with 1<sup>st</sup> month's payment, \$50 registration fee, a copy of child's birth certificate, and a recent utility bill to show proof of residence.

You may pay for the Kids Connection program in full or you may choose to pay with our automatic monthly credit or debit card plan (EFT). If you plan to pay in full, payment is due in its entirety with the \$50 registration fee at registration. If you plan to use the EFT method of payment, please complete the EFT form. First month's payment with \$50 registration fee is due at the time of registration. For students enrolling for a class that meets on a MWF/M-F EFT deductions will be debited from accounts on the 3<sup>rd</sup> Wednesday of every month from September 2018-April 2019. For those enrolling in a Tu/Th class, deductions will be on the 3<sup>rd</sup> Friday of every month from September-April. If your card is declined or if payment is not received for any reason there is a \$25 decline fee.

*Completed registration forms will be accepted by the front desk staff at Arrowhead Community Center only. Forms may be turned in any time February 19-February 23.*

Due to the amount of children that we have in our program, we will NOT accept special requests for teachers, classrooms or students to be placed in the same classroom under any circumstances. All teacher/classroom assignments are made randomly. In the case of twins, triplets, etc., parents have the choice of keeping the children in the same classroom or putting them in separate classrooms, however, they will not be able to request teacher or classroom location.

You can expect to receive an e-mail confirmation in August confirming you child's preschool days/time. At that time please visit our website, [www.channahonpark.org](http://www.channahonpark.org) for other forms including the Preschool Parent Handbook and Child Emergency Information form. This paper work must be completed in order for your child to attend preschool.

Once you have successfully registered for the Kids Connection program, if for any reason you need to withdraw before the start of class, or if you have any questions or concerns about registration, please contact the park district at 815-467-7275. Channahon Park District will retain \$50, as the non-refundable/non-transferable deposit.

**A preschool parent meeting will be held on Sunday, August 26 at 6:00pm at Heritage Crossing Field House. During the meeting you will meet the preschool staff, learn about what you and your family can expect and what we need from you to ensure a fun school year for everyone! There will be time for questions and answers. One parent/guardian of all registered preschool students should attend.**

Students will learn teacher assignments at the Parent/Student Meet The Teacher Day in September. MWF/M-F Meet The Teacher Day, September 5. Tu/Th Meet The Teacher Day, September 6.
