Spear Financial Aaron Gold was present and stated that McHenry Savings Bank won the bid for the Bond in the about of \$685,095 at 2.5996%. Leonard suggests that we cap the resolution approving the waiving of competitive bidding to \$50,000. Each resolution will be specific to each project. Park Planning Manager Cole state that in early May a wash out near Bell Road in Arroyo Trails we had Chamlin Associates come out and bid for repair on the extensive damage in September. Chamlin will work closely with three contractors and they will handle everything in the amount of \$13,500. Motion by Commissioner Geldean second by Commissioner Clower to accept Chamlin Associates, Inc. for the repair of Arroyo Trails. Upon a roll call vote, the following Commissioners voted aye: Geldean, Caldwell, Clower, Babich, Lehman. Motion carried 5-0 with no absence.

Superintendent of Finance & Human Resources Munkvold presented the Fall 2019 Computer Rotation. <u>Motion by Commissioner Geldean second by Commissioner Babich proceed with the Fall Computer Rotation.</u> Upon a roll call vote, the following Commissioners voted aye: Geldean, Caldwell, Clower, Babich, Lehman. Munkvold presented that we cap vacation accrual at 320 hours which is 8 weeks. It has been decided to table this to next month to possible lower those hours more. We would like to Grandfather a small amount of employees that have accrued more than that amount of hours.

Six days we don't pay out at the end of employment. Anything about 240 we currently have \$75 per 8 hours goes towards retirement service credit for retiree insurance premium.
