# **EXECUTIVE DIRECTOR'S REPORT**

Executive Director Leonard recommended that the District take out a Promissory Note in the amount of \$450,000 instead of Tax Anticipation Warrant to carry the District into June when we start receiving tax revenue. In May we will have details on how we will move forward with the future plans and restructuring, due to the pandemic.

The process of restructuring of our Bonds will start in June. Arroyo Trails is looking good and taking shape. The retaining wall will be going up soon.

# **STAFF REPORTS**

Director of Golf Operations Huber is working with Golf Outings to possibly change dates. Huber is preparing to open the course as soon as the governor lifts golf off the Stay At Home Order. If carts are allowed to be used, we will need more staff to clean and disinfect the carts after every use so we will need more man power. A price increase for carts to go up to \$20 will help cover the cost of cleaning and extra staff needed.

Would like to run a Range Program which is an EFT to see if this could bring more revenue. Another way to generate revenue is to do a gift card promotion.

Huber would also like to thank the Full Time Staff and Mike Leonard for all the hard work they have done to help keep the course maintained to get ready to start to play.

Brian Krolack and Mark Uribe have started back to work today to get the building ready to open even if it is in phases.

Communications & Marketing Manager Mensik stated that Marketing has been rather busy most communication to the community is either thru Social Media or Email. Abbie has been busy on the Social Media side using her dog Axel to connect with people.

The summer guide is going to the post office tomorrow. We will start taking registrations on May 4<sup>th</sup> whether the building is open or not. Marketing is trying to keep everyone informed and engaged to keep the public up to date on what we are doing.

Superintendent of Recreation & Facilities Knutson staff is working hard with Marketing and trying to keep programs running. Our soccer program will be pushed back till late summer. Leonard commended the staff that had the Easter Bunny ride around town and Program Manager Vaira had the Preschool Teachers out in the parking lot so parents could drive their kids around to waive to the students.

Commissioner Lehman has asked if we are bringing in part time staff or if we have lost anyone? Leonard stated we are keeping very limited part time staff and not hiring seasonal staff this year. Leonard also stated that next year we will need to look at new software because our current Rec Software is not up to date with new features.

#### **NEW BUSINESS**

Leonard presented the Promissory Note Ordinance #372 is what the Board has to pass in order for the Park District to go forward with the loan. Motion by Commissioner Lehman second by Commissioner Geldean to accept the \$450,000Promissory Note Ordinance #372. Upon a roll call vote, the following Commissioners voted aye: Caldwell, Babich, Geldean, Lehman and Clower. Motion carried 5-0 with no absences.

Leonard presented the GO Park Bonds, Series 2020A – Engagement Letter Speer Financial. Motion by Commissioner Geldean second by Commissioner Lehman to accept the GO Park Bonds with Speer Financial. Upon a roll call vote, the following Commissioners voted aye: Caldwell, Babich, Geldean, Lehman and Clower. Motion carried 5-0 with no absences.

Leonard presented the change of 4.13 Use of Recreational Facilities & Programs to take out that Commissioners are eligible to use our facilities for free. Currently, under the policy free facility use is considered as a benefit and needs to be removed. Motion by Commissioner Clower and Commissioner Geldean to make the change in Personal and Policy 4.13 Use of Recreational Facilities & Programs. Commissioners present voted aye; motion carried.

Munkvold presented that our new auditors would like the 5.15 Capital Asset Policy to the Board Manual. This has always been a procedure of ours but not a written policy. Motion by Commissioner Clower and Commissioner Geldean to except the 5.15 Capital Asset Policy. Commissioners present voted aye; motion carried.

Commissioner Caldwell would like to take the time to Thank Leonard and the Staff for the hard work during this difficult time.
