Privacy Policy

Introduction

The Channahon Park District ("Park District") is committed to maintaining your online privacy. The Park District does not collect personal identifying information about you and/or your dependents except when you specifically and knowingly provide it.

The following explains the Park District's privacy policy for all visitors.

Disclosure of Personally Identifying Information

Your name, when linked with another identifier such as your address, telephone number or other personally identifying information, is private information and will not be given to the general public, including third parties for direct mail or advertising purposes. The Park District needs this information to enroll a participant in a recreational program or membership, and to be able to contact you, if necessary. If you do not provide the information, the participant may not be able to enroll in the requested program or membership.

The information you provide may be released to: persons authorized to have access to the information under state or federal law; persons authorized by court order to have access to the information; persons to whom you have given written consent to have access to the information; and all individuals employed by or entities under contract with the Park District who have a need or a right to know the information in order to administer, manage and improve Park District programming or services.

Security

Your Channahon Park District account information is password-protected for your privacy and security.

The Park District uses industry-standard encryption to protect the confidentiality of the information you submit to us during online interactions. The Park District takes the security of your personal information very seriously. Online Park District services protect your personal information during transit using encryption such as Transport Layer Security (TLS). When your personal data is stored by the Park District, we use computer systems with limited access housed in facilities using physical security measures.

Sale of Data

We do not sell data for direct mail or advertising purposes.

Information Gathering and Cookies

If you visit our websites to read or download information, such as event schedules, facility locations, or job openings, we may capture and store information to speed up the performance of web page delivery.

A cookie is a very small text file inserted onto your computer by a website that you visit. When you return to the website, the cookie is then read by the site's web server. Cookies are used for many things, from making websites more personal to tracking your web browsing habits.
