Commissioner Scaccia inquired about the status of looking at cost averaging in determining our electric bill. Director Leonard said there has been little progress on cost averaging however, he said he is looking into solar to reduce the District's energy cost.

STAFF REPORTS

Recreation Board Report – August 2023

Summer Camp ended on August 4. Summer camp ran from June 5-August 4. There was a total of 539 participants that attended the Day Camp program. Sessions were broken up into three, three-week sessions. Each session we had an in-house entertainer come out, we visited the bowling alley and minigolf course and had one off site trip. As always, our Tomahawk Aquatic Center was a big hit for the hot summer days. Staff sent out a survey to get feedback from participants and there were lots of positive comments about Day Camp. Revenue for summer camp was up this year and brought in \$241,185. After the Bell after school program started on Wednesday, August 16 with 25 participants enrolled. The After-school program is held at NB Galloway school. Staff have planned a lot of fun activities and games for the first couple of weeks.

Preschool and Early Childhood teachers and staff have been coming in to get the classrooms and curriculum ready for the school year. Preschool registration is going well with a total of 98 participants enrolled for the 2023-2024 school year with participants still registering. Preschool and Early Childhood classes will begin on Monday, September 11.

Soccer and Flag Football league begin practices the week of August 28. There are 24 soccer teams and 12 flag football teams this season. Staff held a coach's meeting for both leagues on Wednesday August 23. There are a total of 268 participants in soccer and 147 in flag football.

On Wednesday, August 16, Park District staff helped run a craft table for the Three Rivers Festival Special Needs Day. Participants were welcomed to make a sand art project. The festival had over 1,600 participants registered for the day.

The one-mile Family Color Run was held on August 18 at Central Park. There were 188 participants enrolled in this event. Participants ran one mile while getting sprayed with color. At the end of the event, participants were encouraged to join Park District staff at the Family Stage at the Three Rivers Festival. The stage had DJ Base, a foam pit, and glow sticks.

Registration for Fall started on August 25. The Fall brochure was completed by marketing staff and sent to residents in the middle of the month.

Dimensions Fitness Center

Dimensions Fitness Center is in the middle of the summer downswing for facility use. We currently have 897 fitness center members and an additional 147 track or gym members. Of the fitness center members, 510 are EFT memberships.

in revenue. July revenues exceeded the prior year revenues by \$49,321. F&B revenue was \$22,979 more than the prior year. Golf revenue was \$26,342 better than prior year.

August is off to a good start on the revenue front. Through the first 22 days of the month, we have generated \$277,253 in revenue through our point-of-sale. That is \$37,067 better than the prior year through the same period.

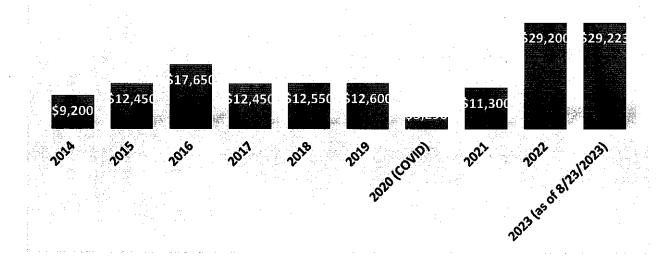
