Thank you for your interest in the Kids Connection Preschool at the Channahon Park District.

Registration for the 2024-2025 school year will begin on Monday, February 26, 2024, for residents and non-resident registration will begin, Monday, March 4, 2024. Our preschool program will start the week of September 9, 2024.

Kids Connection Pricing:

Tuition is based on the total number of days that the class meets and is divided into nine equal payments. Your first month's payment is due at the time of registration. Subsequent payments are due the 3rd Friday of each month beginning September and running through April 2025.

WAIVER, RELEASE OF ALL CLAIMS, AND HOLD HARMLESS AGREEMENT FOR CHANNAHON PARK DISTRICT. PLEASE READ CAREFULLY.

The Channahon Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Channahon Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for this program must recognize that there is an inherent risk of injury when choosing to participate in recreational programs/activities.

WARNING OF RISK

Recreational activities/programs are intended to challenge and engage the physical, mental, and emotional resources of each participant. Despite careful and proper preparation, instruction, medical advice, conditioning, and equipment, there is still a risk of serious injury when participating in any recreational activity/program. Understandably, not all hazards and dangers can be foreseen. Depending on the activity, participants must understand that certain risks, dangers, and injuries due to inclement weather, slipping, falling, poor skill level or conditioning, carelessness, horseplay, unsportsmanlike conduct, premises defects, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor recreational activities/programs exist. In this regard, it must be recognized that it is impossible for the Channahon Park District to guarantee absolute safety.

Waiver and Release of All Claims and Assumption of Risk

Please read this form carefully and be aware that in signing and participating in the programs/activities you have indicated on the reverse side, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injury, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with said programs/activities (including transportation services/vehicle operation, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities and I voluntarily agree to assume the full risk of all injuries, damages, or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) because of participating in these programs/activities against the Channahon Park District, including its officials, agents, volunteers, and employees (hereinafter collectively referred to as "Channahon Park District").

I do hereby fully release and forever discharge the Channahon Park District from all claims for injuries, damages, or loss that my minor child/ward or I may have, or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with these programs/activities.
